EXECUTIVE SUMMARY

INTRODUCTION

Mulranny Community Futures undertook a targeted Geosurvey focused on 3 key sites in Mulranny, see Map 1.

The Geodesign is focussed on 3 adjoining areas in Mulranny; Saint Brendan's Village, Mulranny Amenity Centre, and adjoining Mayo County Council lands (formerly Friese's). Residents were invited to take an aerial view, to ponder and consider. Geodesign is a new way of looking at our world and sharing ideas.

Step 1 is an online "Geosurvey" open to everyone. Suggestions were anonymous and will be included in a master plan. See link https://survey.geodesignhub.com/j4jd/. The online survey ran from 19th May to 06-July. In addition there was a manual option available in paper format up to the 16th of July.

Suggestions were recorded under 10 themes; 1. Public Spaces, 2. Green Infrastructure, 3. Transport Infrastructure, 4. Residential, 5. Water Infrastructure, 6. Agriculture/Food, 7. Enterprise/Social Enterprise, 8. Institutional/Organisational, 9. Biodiversity and 10. Green Energy / Climate Action. No suggestions were made under Biodiversity or Agriculture/Food categories, although related suggestions were made under other categories.

CONTEXT:

Mulranny Community Futures looked to the community for ideas to create social, economic, environmental, or organisational benefits at the target sites, to learn from the community and trial the Geodesign process to empower communities as architects of positive change. Specifically Mulranny Community Futures sought to support Saint Brendan's Village community care endeavours, Mulranny Amenity Centre provision of amenity facilities, Mayo County Council efforts to meet community housing needs. The advancement of the Mulranny Community Futures Plan 2016 to 2021 and the supply of housing in Mulranny was also sought, see link http://bit.ly/MulrannyPlan2016-2021.

RESULTS:

The results, available in full in appendix 1, are summarised under the 8 themes.

RESIDENTIAL:

There was 83 responses and a clear support for the new residential units in Mulranny, with a well-developed site. Comments encourages high-quality design and amenities, access to the Great Western Greenway and a green space for kids. There was also a suggestion relating to community-based housing to support middle income households struggling to access accommodation. A note was made to consider developing the rear of the residential site for residential and retaining the front for public use. Low pillar dark sky compliant lighting was promoted; As Mulranny borders the Mayo Dark Sky Park, which showcases some of the darkest most pristine skies in the world, it is requested that all lighting installed at the new housing estate is environmentally friendly and no more than 2700k, with a preference for zero blue rich light emissions.

PUBLIC SPACES (ALZHEIMER'S UNIT):

There was a clear and resounding endorsement of Saint Brendan's Village and the idea of a state-of-the-art Alzheimer's unit. A 16 apartment Alzheimer's unit in Mulranny, each with their own front door, would form a vibrant and socially inclusive centre open to the wider community with a café, restaurant and hairdresser that would reduce isolation and encourage community life. The proposed unit would be a model for Alzheimer care in Mulranny and County Mayo and would bring many new jobs to Mulranny and the wider area. On a practical note the need to create some dedicated storage space for Saint Brendan's came through as a need.

PUBLIC SPACES (COMMUNITY CENTRE):

There were several suggestions made relating to redevelop the Community Centre, reconfigure it to maximise utility, and utilise for exhibits, band practice, céilí dances, meetings and heritage lectures. It was suggested to add a business hub upstairs in the community centre for hot desking and business services. A suggestion was made to upgrade St Brendan's shop to a mini-grocery shop i.e. bread, milk, ice cream, newspapers etc.

Suggestions came through to enhance the tennis court and encourages its use, extend access from the new playground for expanded children facility or use as an exercise gym (including outdoor space). A suggestion was made to develop the centre as a community resource and tourism facility based on cooperative social enterprise model. Consider reforming the Amenity Centre Committee into a Community Cooperative with annual membership, develop a business plan and phase out life-membership.

PUBLIC SPACES (GENERAL):

There was an array of positive suggestions made relating to the public spaces e.g. outdoor gym, or 5 a side football pitch, youth facilities, use tennis courts for children's play area or community garden. Communal facilities i.e. polytunnel or allotments were suggested. The idea of a public library / remote working hub was mooted, along with an adventure playground, outdoor classroom, and events space.

GREEN ENERGY / CLIMATE ACTION:

Several positive suggestions were made relating to green energy / climate action including hydro, wind and solar energy solutions and a network of solar panels on the south facing community roof spaces as well as additional recycling facilities.

GREEN INFRASTRUCTURE:

Several inventive suggestions were made including a river walk, a weir to create habitat for fish or ducks. A suggestion was made to reuse dry stone walls in a terraced garden scheme and incorporate some accessible raised beds. Retention of the Fuchsia hedges was suggested and extended hedgerows to mitigate road noise and create shade, which could be supplemented with green living walls. A large green area for recreation at the centre of the housing scheme/public was suggested. A landscape scheme, by landscape architect with ecologist input, was proposed.

PUBLIC TRANSPORT:

Several suggestions were made relating to public transport, including a raised footpath from N59 footpath to the Community Centre access door and a new bus stop. Speed humps near playground were suggested.

CONCLUSION:

In looking at the 3 sites there is significant interest and support for the proposed residential development and the activities in the adjoining community owned sites Saint Brendan's Village and Mulranny Amenity Centre. There was an openness to change and achieving high amenity value for the sites and existing amenities.

In conclusion the survey provides guidance to the stakeholders and decision makers on the thoughts of residents and can form a useful briefing document for a multidisciplinary master plan to guide the 3-site development over the next decade. It is recommended that a master plan would be drawn up to further advance the viable concepts suggested.
